It should not surprise anyone to learn that America and the world are played like a fine Stradivarius violin by the elites. These people represent a community of sorts that act in accordance with their commonly share interests, which is the further accumulation of power and wealth from a society which they consider their serfs. Those nay-slayers who perpetually attempt to discredit anyone exposing these nefarious schemes with the practice of tacking theory at the end of conspiracy may well be as dismayed by this booklet as they were by the Satori, Vale, and July 4th 2016 [all of which were eventually blacklisted], that I also I wrote before and whose total distribution now stands at well over 25,000 books.

The beginning

At the outset let me make one thing clear. Conspiracies to rule man is no new issue. In every civilization of recorded history there has been one after another group of individuals who desired to lord it over society for their own benefits. This is unquestioningly a matter of human nature. The concept that some of these conspirators are in it for the benefit of mankind or some sort of egalitarian cause is absolute rubbish. These people in every last instance are about self-empowerment at the expense of the at large society. This in fact is truer of the 19th century concepts of socialism and communism than any other structural political forms. While some have succeeded their tenure has always been short-lived. In proverbs we learn: “*Whoso diggeth a pit shall fall therein*” Proverbs XXIV 27 circa 350-BC.

A wise politician who was certainly a member of the elites, by the name of Benjamin Disraeli (I) was Queen Victoria’s Prime Minister said; “*Politicians are forever in debt to their Masters that provide for their vices*”. One of those vices is their perpetual re-election. In more current term those who pay for the campaigns, the thousands of lobbyists, call the shots on issues relating to legislation.

The conspiracy with which the world is today saddled comes to us from the end of the 17th century, more exactly from the 1780’s. The Illuminist conspiracy, which, always acts as a parasite, attaching itself to one after another-social political or even religious movement to hide its identity espouses the philosophy of Illuminism. Illuminism is the forerunner of communism. The founder of the Illuminist movement that so enthralled the age of enlightenment, (1650 to

1800) was, Adam Weisshaupt (I) and the author of the communist manifesto that Karl Marx (I) and Friedrich Engles (I) plagiarized about one hundred years later, in 1848. The evidence of plagiarism in this case is indisputable. Marx was a German Ashkenazi Jew of mediocre mental ability. He had *Manifest der Kommunistischen Partei* (Communist Manifesto) published in London England by Burghard a Liverpool printing house in old German script because he lacked the ability to translate Weishaupt's (I) manuscript into English. Furthermore the Industrial Revolution (10) was already on the horizon so anyone with a modicum of foresight would have understood the failed ideas proposed in the Manifesto. While the ideas of the Manifesto had application to the 1790's during which time it came to popular acceptance by the membership of the Illuminist movement it ceased to have any social economic or political veracity by the 1860's, and has proven to be a total failure through out the entire 20th century.

Principal players in the age of enlighten were all the intellectuals of the period. All joined the Illuminist cause; Rene' Descartes, Isaac Newton, Francis-Marie Arouet whose pen name was Voltaire, Jean Jacques Rousseau, David Hume, Michel de Montague, Baruch Spinoza, Johan Locke, Goethe and the ever elusive Adam Weishaupt who is never mentioned in history books because all his efforts were secret, who in the long term was to have the most profound impact on Western Society of them all. Just because someone is an intellectual does not mean he is insulated from the acceptance of stupid ideas, particularly when peer pressure is involved.

Illuminism has at various times hidden behind, the Rosicrucian's, the Free Masons, but only in continental Europe, and eventually in the 1890's in Zionism.

For over ten years I have written, spoken, editorialized, and made appearances on behalf of my adopted nation, in what often seemed an elusive effort to save this once great nation from itself. Now in the 21st Century America is on the brink of self-destruction. Gilbert du Motier know in America, as The Marquis de Lafayette was a Freemason dispatched to America by the Gran Orient of France as it was succumbing to the Illuminists to warn Washington of the Illuminist threat. The French Gran Orient was well aware that almost all of the signers of the Declaration of Independence were Freemasons, as was Washington. The German Italian and French Masonic lodges were the second organizations infiltrated by the Illuminati having been preceded by the Rosicrucian's some time before. This by the way is the real reason for the Papacies opposition to the Masonic orders.

I emigrated from Switzerland to America in 1952 at the tender age of 12 and with some interludes in Germany and Mexico I lived in many American states. I have resided in NY, IL, CT, RI, NH, CA, TX, and in NJ. As the CEO of a manufacturing as well as import export business I traveled the world for over 40 years to over one hundred nations. I ran businesses in America, England, Switzerland and the Republic of South Africa. And now in the waning years of my life I am so sadden by the state of things that in this booklet it is my desire to try to wake up Americans to the realities of what the elite's have planned for this

country. I had plants in the UK Midlands, California, Zurich, Randburg (1) RSA, and Connecticut. I developed over twenty US manufacturing patents, authored fourteen books and have been the recipient of scores of awards. All these mean little to me, what matters is America the nation that was the great hope of the post WWII era, a hope that has been dashed by the New World Order. When I came to America in 1952 it was the greatest nation in the world. American's and America was virtually idolized in Europe, as well as the Indian sub-continent. People literally lined up to try for visas to immigrate. America was saving Europe through the Marshal Plan instituted on July 12, 1947 that was gladly accepted by all but the Soviets who turned it down. Massive popular opposition blocked the diabolical Zionist Henry J. Morgenthau, (I,) who had been FDR's Secretary of Treasury plan to de-industrialize Germany. Morgenthau from a wealthy NY family was one of the Satori.

None dare call it treason. Also the title of a very interesting book

I am a "True Believer" (Also then name of an excellent book by Eric Hofer) in a worldwide conspiracy, as those familiar with my writings will inform. Those who oppose conspiracy will add the word theory after it, or will in vain effort trivialize the enunciator of it, or to ridicule those who pronounce it to be fact. Because of their weak position regarding facts their most usual effort is related to attempted character assassination or the invention of slander against the author. If all else fails they will bring frivolous lawsuits in effort to destroy their opponent through legal bankruptcies. To people who oppose conspiracy as a viable historic fact I say, do you plan your day when you get up? Does your employer have a business plan? Does you mortgage holder have a plan to collect from you? Do governments, and corporations plan for the future? Do farmers plan what crops to plant and when to plant and harvest them? The answer is an emphatic yes to all those; so why would anyone reach the asinine assumptive conclusion that all of history is happenstance, that there is no order or planning of societies, nations, nor any organizations that institute any such strategies. Such people should read more, especially *Tragedy and Hope* by Quigley (CFR) and *Between two Ages* and *The Anglo American Establishment* by Brzezinski. (CFR, TC, B, BG)

A major problem existing in exposing the conspiracy is that few people really understand the nature of the beast. Most seem to concentrate on one or another group of secret or semi-secret organizations never realizing that almost all of these are front groups. Neither do most understand the way secret organizations are structured or the way they attain their goals. Per example the largest semi-secret organization in America is the CFR (Council on Foreign Relations). In the last few years they have become less secretive their membership list that now stands at about 4,100 the CFR is widely published, and they circulate their flagship publication *Foreign Affairs* that outlines their basic plans for the world and America. While the general membership of the CFR understands the basic premises of the organization, i.e. world government, single currency, elimination of nation states, international law trumping national laws, total citizens' gun confiscation, and so forth, they look upon these issues as long range goals having no immediate impact on today's society.

How does the CFR function? Since the election of FDR with very few exceptions every member of the cabinets of all presidents have been CFR members. In order to gain rapid advancement in the military, Dwight Eisenhower, (CFR) Alexander Haig, (CFR) and David Petraeus (CFR) per example, have been members. Almost all Joint Chiefs of Staff have been members. Those who were not CFR were TC (Trilateral Commission) members an offshoot of the CFR.

Then there are the foundations and “think tanks” that are completely controlled by this same group of individuals.

Structurally virtually every secret and semi-secret organization functions in similar manner. The organizational structure is pyramidal, however the pyramid that the public and general membership sees is a sham. In every instance the leadership of that pyramid holds uniform membership in a second tier structure that is also pyramidal. This type of structure may contain up to 40 levels of advancement in which the general membership below the third tier is totally unaware of the existence of higher tiers of membership. In this manner the leadership on top is never exposed because none except other upper leadership members are even aware of its existence. Thus upper tier members of whose higher position the general membership is unaware control the lower levels.

David Rockefeller (TO, CFR, TC, B, BG, I,) (Born. June 1915 -) is the consummate insider, is a Bonesman, was for many years the chairman of the CFR and was the founding member of the TC and has also been involved in the Bilderberger group. The Rockefeller family has controlled the Chase Manhattan bank for decades while holding less then 10% of the outstanding shares of stock.

False Flag Operations:

False flag operations by governments are one of the oldest ploys used by bureaucracies to further their goals of social power over their own population. This is hardly an exclusive of the Nazis in the *Reichstagfeuer*. America has sadly not escaped this. The Oklahoma City bombing of the Murrah Federal Building on April 19, 1995 was the first large scale effort by the American government to create a socially political situation that would allow the bureaucracy to implement legislation empowering it to more effectively control the citizenry. Coming shortly as it did, after the Ruby Ridge incident, in which the US Marshals and FBI were eventually found to have been on the wrong side of justice it failed. A much larger incident was needed to implement the Patriot Act that had been written four years earlier and a newly organized Homeland Security Department patterned after the infamous WWII German models. Their second attempt was on February 26 1993 a bomb attack on the World Trade Center in which the FBI actually supplied the explosives in an attempted sting operation gone awry; it also failed to produce the desired effect. Then came the coup-de-gars, the September 11, 2001 attack on the WTC now called the 9-11 incident. The whitewash of the 9-11 commission is so fraught with mistakes and false and missing information that it has no viability at all.

On July 16 2001 the British joint Intelligence Committee, as reported in the London Times informed their counterparts in the United States that a terrorist attack was in advanced development stages against a target in NYC. Based on

further information from German, Russian, as well as our own agencies there could be only one target in NYC for such an attack. After the attack Op-Ed News published an article in which no less than seven FBI agents called the report a cover-up. Then 25 FBI agents volunteered their services to congress to form an independent committee to form an investigation, they were ignored.

So, let's look at the available facts. Never in the history of high-rise buildings had any such structure ever collapsed upon itself in any way or manner due to fire or any other issue. On Feb 13 1975 an intense fire consumed the 6th floor of North Tower, it took over 120 firemen more than three hours to control the fire no damage of any steel was noted by fire inspectors. Four days before the attack on Friday September 7th huge and inordinate stock put options were placed on American and United Airlines the carriers whose planes eventually crashed into the buildings. These options were over ten times the normal trading volume for the NY & Chicago Markets and reaped its investors millions of dollars. The twin Towers had already been grossly over-insured by its owner. Allianz and Swiss Re-insurance were able to subsequently have insurance values reduced by millions of dollars. Photos of the rubble before the almost immediate removal of debris showed steel columns that looked as if they had been cut by Plasma, which is exactly what thermite explosives do. Thermite that contains aluminum and iron oxide burns at 3,000 Deg. F. The steel used on WTC has a melting temperature of 1,810 Deg. F. and all columns were covered by almost one foot of concrete. Jet fuel when ignited and under high airflow can produce the maximum temperature of 1,600 Deg. F it cannot melt or even severely weaken steel covered with concrete to the point of collapse. Later after the incident, several national as well as NY based insurance carriers as well as fire inspectors bitterly complained about the clean-up having been started long before any workable inspection of cause could be made. There exists no known record of a steel column built building collapsing down upon itself without the use of timed explosives progressively detonated. Film on the Internet of the collapse clearly shows concrete steel and building materials horizontally flying out of the building to distances of up to 400 feet, No existing film of any building collapse without explosives shows any such action. Over 600 human bone fragments were located on the roof and inside of the adjacent Deutsche Bank building, opposite the directions of impact, the only way they could have gotten there is by an explosion.

Finally the scores of lawsuits against the government relating to 9-11 have all been kept from jury trial by either bribery payments or intimidation. The largest suite brought by Stanley Hilton for murder against George W, Bush and key administration officers has been continuously sidelined, Hiltons office has been ransacked and broken into numerous times, Hilton has been threaded with disciplinary action by the US Federal Court in San Francisco, and Chief Judge Marilyn Patel told him she does not like the case and he should drop it. From the afore information you can draw your own conclusions.

The Federal Reserve System

As we all understand money makes the world go around. It's a saying so old that no one can tell where it originated, and it is the truth. Since the very founding of America the banking elite, the Satori, or Illuminati, or whatever you desire to call them have been at the forefront of taking over our government. As Disraeli (26) so aptly put it "*The World is governed by far different personages from what is imagined by those who are behind the scenes.*" Their efforts were repeated no less than three times before they succeeded with the creation of the FRS. The bankers used the fallacious excuse that they would be able to better control the markets and prevent depressions and monetary fluctuations and by these means save the Republic. The great worldwide depression of 1893 was used as the whipping boy for this lie. Nevertheless the worst congress of history in 1913 acquiesced and the FRS was created. From 1913 the bankers manipulated the markets for fun and profit to themselves causing the great depression of 1929 a short 16 years after their founding, then America and the world was taken on a rollercoaster ride of market undulations in the 70's the 80's, and yet again in 2007-8-9.

In simple terms the bankers in collusion with the government manipulate the markets, monetary values, the economy through taxation, excessive spending, governmental regulation, and wars, all of which cause inflation and in our most recent case stagflation all of which cause market distortions that due to natural forces then unwind to cause depressions and undue market fluctuations. Since the bankers and high government officials cause these things to take place they are and remain the ultimate market insider traders reaping huge profits for themselves every time they cause the markets to fluctuate.

The FRS is not federal, it is not a reserve because it has no reserves, and it is most certainly not a system it is a corporation incorporated in the state of NY. Look it up in the NY Times September 23 1914, which lists the stockholders. The creation of a cabal of Illuminist bankers from 1910 to 1913 when on Feb 13 the 16th amendment was passed it facilitated the enactment of the Federal Reserve Act that took from congress the peoples right to coin money. A detailed accounting of this is found in my book *July 4th 2016 The Last Independence Day*. For more expansive information you may wish to read *The Secrets of the Federal Reserve* by Eustance Mullins the friend and protégé' of Ezra Pound America's greatest poet.

The Federal Reserve System that has been the prime culprit in these market fluctuations which has made you poorer and them richer is now according to the Secretary of the Treasury Henry Paulsen (B, BG, CFR) to become the regulator and auditor of the banking industry. There are by the way only two agencies of the American Government that have no oversight and have never in their histories been audited, The FRS and The Treasury. Talk about the fox guarding the chicken coop!

The actual result of these FRS policies is as follows:
Actual inflation from winter 2007 to summer 2008:

- Meat and Dairy Products 7.231%

- Field Crops 56.955%
- Fruits 15.482%
- Vegetables 16.99%
- Fuels 68.90%
- M-3 Money supply 18.10%

Average inflation rate US in current dollars 2007-2008 summer 30.60%

This unprecedented in America rate of inflation coupled with artificially lowered interest rates, used to keep the banking sector afloat, by the FRS will cause market turmoil. The FRS has painted itself into a proverbial corner between inflation and dollar devaluation on the one hand and rising prices, dropping real-estate values and the collapse of our economy on the other, and the rapidly falling value of the dollar.

What the dollar is really worth after the elimination of the M-3 money supply report in March 2007 is anyone's guess. However we are able to gauge the dollar's value based on its exchange rates against other currencies and its value in the hard assets of gold platinum and silver. The currencies are the Pound Sterling, The Swiss Frank and the Euro the timeframe is the last 12 months. The result is that the value of the dollar has fallen by just under 33%.

To place this in differing terms what you could buy in 1950 for one dollar today costs \$ 20.00.

In *The declaration of the Federation of the World* published in 1919 the key phrase is "That all people of the earth should now be united in a commonwealth of nations". This proved to be the impetus for Colonel House (I) to bring president Wilson into the New World Order and their first attempt the League of Nations centered in Geneva Switzerland.

The bankers control the governments due to excessive borrowing, and then the governments, through the purse strings, attached to their loans.

- Fractional reserve banking is the process of loaning out 90% of the funds deposited by every customer of the bank.
- Compounding is the process of adding interest already collected to the total amount and then using the arrived on total to do it again.
- In mortgages separation of principal and interest is the process of reducing the total amount by applying larger percentages toward the interest and lower amounts to the principal at the beginning of the payment cycle, also called front loading.

All three of these ideas came from the Babylonian captivity of the Hebrews. For a good book on this issue read *Money a primer* that I wrote in 2006.

Conspiracy in the 20th century:

Organizationally there are scores of elite running around the world with dreams of lording it over all the rest of human society. The most prominent of these are based in the English-speaking world but beginning after WWII they have expanded like an evil Hydra to encompass most of the world, as we know it.

While these organizations are centered in the economic capitals of the world they non-the-less exist everywhere.

The primary foundation of many of these groups is based on the numerous wills and trusts of Cecil Rhodes (F) (2). Today the remnants of this plan can be found in the RIIA (Royal Institute on International Affairs) [Chatham House] (3) another prime player in the beginning of this was the Webbs, (F) Sidney and Beatrice. (4) Sidney founded the leftist London School of Economics and they jointly founded the Fabian Society (4) seated in the Webb House, not the one in Connecticut where Washington met Rochambeau in 1781, the one in England. The Webbs more than anything may be credited with the establishing the British labor party's philosophic basis and the American Democrat party of the 30's whose fundamental point of view mirrors that of Labor in the UK, i.e. socialism. The philosophic basis of socialism is encapsulated in the stained glass window on the landing between the first and second floor of the Webb house, a wolf putting on a sheep's fur coat. Lord Milner (F) (6) was another of the original conspirators for the first phase of the New World Order, which at that time was called the Anglo American Establishment. His primary contribution however was Milner's Round Table, (Lord Milner). The Group was another forerunner of the present elite organizations.

A little about hard assets

Hard assets are gold, silver and platinum. In today's markets we consider gold and silver as the ultimate backing of currency. America stockpiled over a billion ounces of silver until the late 70's when the government began divesting itself of our silver horde. Who got the proceeds from the sale remains a mystery. The incredible stupidity of that action is supported by the fact that silver has increased in value since the 70's by about 660%. The old adage of sell high and buy low missed the entire bureaucracy. Likewise our gold horde has been depleted by over 80% of the original deposits. Thereafter the dollar was backed by debt, and today it is backed by nothing. This is especially true due to the over four trillion Dollars of new paper issued in the second term of the Bush administration, backed by nothing.

Everyone today realizes that in this age of stagflation the only real holding that is secure is silver and gold. Most people consider the price of the commodity as the prime consideration for purchasing, but that is a mistake. In virtually all cases the reason for the buy is in defense of personal asset holdings, and because trust in the dollar, banks, brokerage houses and the government are far down the ladder of consideration. People understand that in times like these hard assets are a time proven hedge against inflation, stagnation, devaluation, and all the other stigmas presented to us by government and banking. What the buyer wants is protection of the purchasing power of his assets. What he wants to do is to minimize the risk to his holdings. When we examine our banking industry and notice the failure of Northern Rock in the UK, Bear Stearns in the USA, losses of

over \$ 30 billions by Citybank the largest bank in America and UBS the largest bank in Europe we begin to get worried, and justifiably so.

The prime error made is that many people consider gold an investment, which it is not. An investment produces a earning; gold and silver do not produce any earnings. That is because in all investment there is a consideration of risk, which is the reason an earning or return is produced. There is no risk in holding gold or silver its value is constant and has been stable for thousands of years. Gold and silver preserve wealth they do not increase it. To look at gold or silver as cheap or expensive is a misnomer; it is not the value of the metal that is fluctuating it is the currency used to buy it that continuously changes.

INFLATION: *In about 1815 one English pound was equal to 10 Gulden, or 20 franks or 5 Tahler. Consumer prices have risen about 5,800 percent between 1815 and 2008. Thus one English pound in 1815 has an approximate value of about 580 English pounds today or 125 silver dollars or \$2,170 US fiat paper dollars.*

The Fabian Society:

Founded on Jan 4 1884 by Sidney and Beatrice Webb (F) the society is the primary carrier of socialist political and social philosophy worldwide. In 2008 they remain to have considerable influence particularly in the British trade union movement and the British labor party. Tony Blair (R, B, F) (7) the British Labor PM who so dominated UK policy after his defeat of Lady Thatcher who proceeded him by an 18 year rule, is a member of the Fabians. There are several foreign Fabian seats mainly in Canada as the Douglas Caldwell Foundation in Australia as the Australian Fabian Society and in New Zealand as the League for Social Reconstruction. Prior to Lady Thatcher the Fabians almost succeeded in total destroying the English economy through their diabolical socialist agenda of nationalizing everything in sight. The UK had the worlds most advanced aircraft industry when they came to power after WWII and they utterly destroyed it by nationalizing the entire industry. This led to the brain drain (8) by which most professionals and intellectuals my wife included, left England for various commonwealth nations and America.

Early Fabian members whose names you will recognize were: George Bernard Shaw, H. G. Wells, Annie Bosant, Virginia Wolf, Social socialist philosopher Bertrand Russell, (R) the communist Harry Dexter (CFR) White who was instrumental in the foundation of the UN, and last but surely not least John Maynard Keynes (F) the man whose economic catastrophe was adopted at the Breton Woods conference in Northern New Hampshire in 1944 that has caused the massive inflation of the dollar by deposing gold as the basis for monetary

valuation and replaced it with fiat money. No single other act of anyone in the last 100 years has had such a devastating effect on society. It is the means by which Americans are gradually being reverted to serfdom. It is the reason that average middle class income in real terms has declined every year since 1950. It is the reason for the meteoric rise of the value of gold silver and platinum, in indeed all commodities. It is the reason that America in the 21st century has become a two-class society, as was the rule in the Dark Ages. This cycle of Keynesian economics, which is based in socialist philosophy, has come to fruition with one of the last acts of the Federal Reserve System's Alan Greenspan in March of 2007 when he stopped reporting the M-3 money supply data. The M-3 simply reported on the amount of new fiat paper issued vs. used bills destroyed. It's reporting allowed bankers and economists to gauge inflation because it allowed them to calculate the money supply expansion.

World currencies due to deficit spending by governments and the Keynesian economic platform are no longer based on hard asset (gold and silver) but on debt. In other words the value of the dollar could be calculated based on the amount of new fiat species issued vs. the known gold and silver holdings of the Treasury. The debt backing is based on T-Bills and other government loan instruments sold as interest bearing notes whose value is then used to issue new fiat species. Without the M-3 money supply report the value of the dollar cannot be established. The American government sold all of its silver holdings in the 70's 80's and 90's and today has no silver holdings. Gold holdings have been severely depleted and now stand at less than 10% of the issued fiat paper currencies in circulation. This is but one of the legacies of the Fabians.

It is unquestionably the preview of the Fabians that monetary policy of the pre WWII era was replaced with the irresponsible policies of the post war era. The primary legacy of these economic socialist policies has been the rapid decline in income of Americans whose disposable income in real value has declined every year since 1950. and since the 1944 Breton Woods conference the gradual elimination of any hard backing of all world currencies.

A simple example of this is the presently rapidly rising price of gasoline (Petrol) In 1947 a gallon of gas cost \$0.25 cents. Quarters in 1947 were made of silver. Today silver is at \$ 17.60 per ounce. and gasoline is at \$4.12. As you can see the price of gasoline has been stable in the terms of hard asset, i.e. silver. What has taken place is that government in collusion with banking has inflated the dollar (9) banking and government is always partners in the crime of defrauding the people.

Let me be plain and up-front. The elite's or Satori is the monied interests primarily seated in the banking, investment banking, brokerage, hedge fund, arbitrage, and large multi-national corporations industries. I am not speaking of your local banker or stockbroker but the manger-owners of these industries located in NYC. London, Zurich, Tokyo, and Frankfurt.

The Fabians are related to Cecil Rhodes through his wills and trusts that provided the financial means for this organization to become a prominent player in British and Commonwealth policies beginning before WWI and up to the turn of the 21st century. Zbigniew Brzezinski, [CFR, TC, B, BG] wrote a book called The

Anglo American Establishment, but the seminal tome is Professor Carroll Quigley's [CFR] 1400 plus page book *Tragedy & Hope*. So angered were the Satori by the publication of *Tragedy and Hope* that they purchased the entire print run they could get their hands on and burned it. Fortunately GSG Associates of Rancho Palo Verde's CA was able to obtain a copy and republish it.

To explain; the Fabian society has evolved to become part of the cabal of leftist world organizations whose goals are identical and all encompassing with those of the Bilderbergers, CFR, TC. And RIIA while this is far from all those secret and semisecret organizations in existence, they are the major ones. We will delve into the various Satori organizations later in this booklet, before we are able to do that the reader must have a historic and structural understanding of the issue.

The issue of wars

Let me clarify one important matter that relates to all the major military conflicts from 1900 to 2008. The impetus for war is based in economics and power politics. While the "Sheeple" are induced into accepting reasons for war as being based in patriotic, religious, social, economic, empire and other terms the wars, are caused by only one issue; the desire of one group of people to gain economic and political power over another group. Patriotism is the fool's first mistake when he accepts the pronouncements of leaders to fight for honor, country and family, or for the protection of all he holds dear. The fact of the matter is that terms of patriotism are always couched in fallacious ideology specifically designed to induce young people to sacrifice their lives on the altar of the Satori. Governments for eons have used false flag (11) operations in order to incite their Sheeple to sacrifice their lives for one after another silly notion. Along with this is the creation of a bogie man whom the Satori can then use as the whipping boy to point to as the group responsible for all of societies woes. This would be, Palestinans by the Zionists, Muslims by the Bushists, Jews and gypsies by the Nazis, and Islamo- Fascists by the Neo-Con [Zionists]

Wars however take many different forms; they need not necessarily be military wars. Consider per example the war on drugs alcohol, poverty, three real losers. The war on drugs that was initiated by tricky Dick Nixon in 1972 cost America 66.8 billion in 1998 and that expense was up to \$145.9 billion in 2007 in other words it about doubled in seven years. What did we get for that, nothing, the average drug usage since the beginning of the program to today has remained almost constant. Before that in 1964 LBJ (President Johnson) started his great war on poverty, (The Great Society) the nations largest boondoggle in its entire history. Since '64 America has spent over 4 trillion dollars on this bureaucratic nightmare that more than anything was the plan of Democrats to induce Blacks and the poor to vote for them based on group politics. Group politics is the process of funding special interest or ethno-centric groups so that they will vote for you. Read the Constitution and Bill of Rights I will give anyone who finds a group right in any of these documents a \$1,000 dollar bill.

Wars as you can see are the stuff that makes the Satori method of "System Politics" work. In my book *Our Political Systems* I explain in great detail how America now has one political party that I called the Republocrats, and that this party is a system of governing, which is totally controlled by the Satori. There are those who would dispute that claim, to them I pose the following questions.

- 1) With a congressional and executive incumbent re-election rate of over 87% and a participation in the legislative and executive branches of government 99.9% members of the same political parties (the Republocrats) how can you possibly justify the concept that we have two parties, or are a democracy?
- 2) In the 2004 Election the two running candidates Bush and Kerry were both members of The Order [Bones, 322] whose political philosophy displayed no variance and whose nomination by their parties were arranged by the Satori. How can you call such a process democratic?
- 3) In the 2008 coming election between Barack Hussein Muhammad Obama and John McCain there aside from some minor issues, are no differences. All this is, is a repeat of 2004 where the sheeple have no choice, how can you call this anything but a sham?
- 4) With congressional staffers, and executive workers being recycled by both Republocrat parties regardless of who is elected, how can you anticipate any possible change?
- 5) Thinking back to the beginning of any election cycle have you personally ever had any impute into who the eventual candidates were? Or did you ever once get to vote for a candidate you first picked?

These are basic questions relating to a democratic form of governance, to a republican administration. If you honestly can respond that you are satisfied with the candidates, happy with the system, contented with the judiciary, and joyful with the executive and happy with the legislative, you are a member of the smallest minority of Americans.

Without regression, and because the Rothschild's (I) are an integral part of the conspiracy, let me tell you the fascinating story of the Rothschild Banks from its founding to the end of the Napoleonic wars.

The House of Rothschild

Banking had numerous major changes throughout history, of these the most interesting and long lasting was the loss of banking monopoly held by the Knights Tempar (13) to the Jews. The religious concept that the charging of interest was a violation of Christian, Islamic as well as Hebrew law is not commonly known today, however Biblically it is not allowed to charge percentage interest for a loan by any of the believers of the Book to another believer. (12) Islam still practices this law, (14) Christianity has dropped it and Hebrew's still practice it but Jews do not. The Jews through their considerable influence with

the French King Philip IV, who was extensively in debt to the Templars succeeded in getting Philip IV to bring false charges against the Grand Master of the Templars Jacques de Molay and all the leaders of the Templars. The sitting Pope of that time was Clement the V a very vacillating and weak Pope who bowed to the wishes of Philip. Philip subsequently was able to write off all the millions he owed to the Templars and start all over with the Jews. An interesting historic side note is that most of the Templars succeeded in escaping with over three fourths of their huge fleet and most of their treasure, where they went is not to my knowledge recorded anywhere. The reason that this is so important is because the Hebrews had succumbed to Nebuchadnezzar's Babylonian empire in 586 BC and all the Hebrew's were brought to Babylon. This is called the Babylonian Captivity. In 539 BC the Babylonians were overthrown by the Persian Empire who let any of the Hebrews who wanted return to the Mediterranean. About half of them did, and brought with them the concept of fractional reserve banking, loaning at interest, compounding interest, separating interest and principal re-payments, and all the other usury practices of modern banking. I will address these issues later in this chapter.

The House of Rothschild was a building located on Judengasse in the Hessian city of Frankfurt A/M in Hestia named *Zum Roten Schild*. The time is about 1780. Jews traditionally did not have Christian names rather using a derivation like David the son of Asher; this proved impractical so all Ashkenazi Jews (15) adopted Sir names usually related to their profession, home, or geography, thus we have Goldschmidt (GER. Gold smith) Rothschild (GER read shield) Eisenberg (GER Iron Mountain) Whatever Rothschild was called before he purchased the house called the house of Read Shield is unknown he adopted it as his Sir-name.

The founders chosen name was Meyer Amschel Rothschild, he however more often then not, in business, used his adopted Christian name Peter Arnold, everyone in the know, was aware who he really was. He rose gradually through the trade of rare gold coins to become the court factor of the richest man in the world of that time to the price of Hestia-Hanau. To make a long story short King George III of England was at this time engaged in the Revolutionary War (16) in America, his press gangs had just about rounded up every able-bodied Scott, Englishman, Welshman, and Cornishman available and he needed more manpower. Rothschild found out about this and sensed a great financial opportunity. George III's first move was to contact hi cousin the Czar of Russia, who was more than willing to sell some of his surfs, however Rothschild intervened and told the Czar that he would call his notes if he provided soldiers to England. The Czar regrettably told his cousin no dice. Rothschild agents then suggested to the British crown that he, Rothschild could possibly help, to which the crown indicated they were more than willing to listen. Gradually a deal was struck between the Margrave of Hestia also a cousin of George the III and the British Crown, it proved to be the first hugely profitable war transaction for the Rothschild bank.

The Deal!

Hessia was to provide soldiers as needed by the British crown. These soldiers by the way were mostly farmers and tradesmen who were rounded up by press gangs and forced into service.

Foot soldier each 51 Tahler (76 Gulden) due within 60 days of recruitment

Double that if the man was lost in combat

One and one half if the man was wounded

Three wounded accounted for one dead at an additional 51 Tahler

If a ship was lost or in battle or a corps was lost the King of England had to pay the entire cost of replacement of the full regiment or corps.

Profit to the Landgrave of Hessia was in the millions just in 1776. However the terms were factored through the House of Rothschild, and the Hessians did not want to wait for their money so Rothschild factored the immediate cash payments for 15%. This is up and above the already stringent fees imposed by the deal as up front fees of well over 7%. Naturally the British pounds had to be converted into Continental currency for which another fee was charged. In total Rothschild banking took 25% of every foot soldier's charge or 19 Gulden each. The war lasted eight years and the contract with Hessia had duration of 5 years. Total number of troops provided 30,067 total lost 12,562 Total cost 2,814,741 Gulden on which Rothschild made 703,685 Gulden in straight profit without the outlay of a penny. Equivalent in today dollars that is over 408 million dollars.

This was only the beginning. The Rothschild bank was more than just clever. By 1815 (battle of Waterloo) various of Rothschild's sons had established huge branch-banks in London Vienna, Naples and Paris and developed the only rapid means of communications in Europe. The battle of Waterloo saw the defeat of Napoleon Bonaparte but that's not the news the Rothschild bank released in London on June 18, 1815. What they reported was the defeat of England. In fact Wellington's contribution is grossly overrated the Prussian octogenarian Gerhard von Bluecher a Prussian general was the cause of the victory. In any event when the news hit London that England had lost, the entire capital markets collapsed and the Rothschild bank bought up all of England's stocks and bonds for pennies on the pound. In the end the London branch of the Rothschild's owed England, and remained as today the richest family in England.

The next big move by the bank was when they bailed out the bank of England after WWI and Lord Rothschild (yes titles are purchased) as president of The World Zionist Federation obtained the Balfour Declaration, which double crossed the Palestinians who had been promised autonomy by First Viscount Lord Allenby for their help to the crown to defeat the Ottoman Turks who were allied to the German in WWI. By the end of the transactions Rothschild owned the Bank of England There is much more to be learned as it impacts America on this diabolical financial institution. Of all the banks in the world the house of Rothschild is by far the most diabolically involved in wars and war profiteering.

The Rockefellers

John D. Rockefeller (17) was the patriarch of the clan that has become the most influential family in America. He was such a curmudgeon that his servants provided him a bag of dimes so that he could improve his image by giving

children dimes. He was the founder of Standard oil, as well as standard oil of Ohio, together with his brother William who died at a relatively young age. One of his friends was Henry Flagler the RR tycoon who eventually became the great benefactor of Florida by not only building a RR to and around Florida but also a chain of hotels and a rail link to the keys. John D. was America's first billionaire.

The offspring of John D. (TO) and subsequent offspring have all one way or another been very politically active. Nelson (TO, TC, CFR) became governor of NY, others senators and governors, one ran for the presidency, but the one who impacted society most was David Jr. (TO, CFR, TC, B, BG) born in 1915. He remains today honorary Chairman of the CFR. (18) He at the suggestion of Zbigniew Brzezinski (TC, CFR, BG B) a principal advisor to David as well as the CFR suggested the need for a trilateral organization with a membership comprised of Europeans, Asians, as well as Americans at a meeting held at the Rockefeller estate in upper Westchester County, NY on the 23rd of July 1972. The new organization would come to be called the Trilateral Commission with about 340 members mostly in America, Japan, and Western Europe.

Who's running things?

There is a small number of secret and semi-secret organizations we are able to identify as the leadership organizations of a worldwide cabal all with one exception having been created in the 20th century. In order to list these organizations I am using a historic sequencing based on their founding date, with one exception. This means of listing will allow the reader to develop the proper sequencing of events and enable better understanding of the issues. Unlike my first book on this issue *The Satori and the New Mandarins* I will not list all the names of the participants, only some of the leadership positions. An Internet search of the listed organizations will turn up lists of names in all but one case Bones of which complete lists are and remain incomplete. In the case of Bones however, one can infer membership by family name and attendance of Yale University. And unlike my book *Vale the Illuminati and its plans for the future* this booklet is not intended to provide the philosophic reasons of behavior but is intended to be short and to the point with the sole purpose of waking up our "Sheeple" to rebel against this horrendous injustice under which they now live.

The Illuminati

While the Illuminati is not an American founded organization their imprint on America is paramount and an understanding of their plans and philosophy is required because they are even today in the leadership of so many other conspiratorial organizations.

Illuminism is in straightforward terms the originator of communism as was presented to the world by plagiarist Karl Marx as declared in the first part of America Awake. A detailed analysis of Illuminist philosophy is found in my book Vale. The reader might also avail himself of a translation of the Communist

Manifesto (19) The reader should pay particular attention to the ten points of the manifesto most of which have been implemented in all Western Democracies.

Illuminism in America is seated in The Order, which is a senior organization at Yale University.

The foundation of Illuminism dates back to 1700s. The first public evidence of the Illuminati dates to 1785. Jakob Lanz was a close associate of Adam Weishaupt (20) the founder of Illuminism and its philosophy that was struck by lightning in that year. Lantz carried with him extensive documents relating to the planned takeover of all possible Masonic and Rosicrucian Lodges in Germany, France and Italy and to then begin to manipulate the governments of those nations.

Adam Weishaupt was extraordinarily young to have inherited the Chair of Cannon Law at Ingolstadt University in the 1700's. This came about due to a Papal Bull issued by Pope Clement XIV severely restricting the power of the Society of Jesus (21) [1773] The Jesuits had held the posts of Cannon law (22) in most universities in Europe for decades. With this prominent position Weishaupt began fantasizing and planning his preparation for the Illuminati to rule the world. They have never deviated from that basic strategy, as you will learn. In the 20th century the Jesuits began their relentless communistic "Liberation Theology" that confirms the teaching of it even in the 17th century that has placed the order in such constant conflict with the Roman church. Pope John the XXIII often spoke and wrote about this issue and the churches opposition to "liberation theology" as a political issue that has nothing to do with the church or its teachings. Weishaupt was educated by the Jesuits from birth through university.

In succession from its first establishment as an organization Illuminism always functioned as a parasitic organization, never exposing itself publicly and always acting through an organization that they had infiltrated and assumed leadership of. In sequence the Illuminati has acted through, 1) the Repercussions, 2) the Free and Accepted Masons, (23) and lastly at the turn of the 20th century through Zionism. If the Illuminati were thought to have a head quarters in America it would be the Tombs in New Haven CT the initiation edifice of the Order. In my book Vale a detailed rendition of the Illuminati and its history can be located in Part I. Beginning PP 1 in my book Vale.

The Order

The Order, has numerous names, these include The Order of Death, The Order, 322, [Chapter 322] Bones, and Skull & Bones. (24) It is the oldest operating Illuminist organization in America, and may be considered the American domicile of the illuminist movement. They originated in the 1850's and have been prominent in American politics, ever since. They are not related to The Group, which is a socialist organization that prevailed for a short span of time in England. The Order of all the secret organizations in America is the most important because members of the Order can be located in the leadership of all other secret and semi-secret organizations as well as multinational corporations, banking media and government. The total membership as of 2008 is about 1000

active members. Remember George Bush Sr. (TO, B. BG, TC) statement in his state of the union address “A thousand Points of Light” Both Presidents Bush (TO, B. BG, TC) as we; as presidential aspirant Kerry (TO) are members of the Order.

The Order came to America by way of Germany and more exactly the old German dueling societies that were so prominent before WWI. The order was incorporated as the Russell Trust in New Haven CT in 1856. General William Huntington Russell (TO) and Alphonso Taft (TO) who later in 1876 became Secretary of War (25) instituted the American Charter in 1883 at Yale University. Alphonso was the father of Bonesman William Howard Taft (TO) 27th president of the United States and the only man ever to hold both the presidency as well as to become Chief Justice of the Supreme Court. He was a close associate of Teddy Roosevelt who was his predecessor as president.

The New Haven Connecticut home of the Order is the Tombs, a two story ivy covered windowless building located on a side street just east off the New Haven green and to the south of the library almost across the street from the Hew Haven Yale club. Don't bother to wait at the front door, none will appear scores of Yale university buildings are interconnected through underground tunnels, the most common way into the tombs is through a door in the restaurant lobby of the Yale club directly on the north side of the Green. There is an extensive volume of information on the Order in my book *The Satori and the New Mandarins* as well as in Vale while the Satori is now out of print is readily available in the used book market Vale is available on the market.

In order for you to fully understand the power of this organization I will list a few names with which you may be familiar: I only provide family names because in almost all cases Bones is a family organization. I might also say that a certain books published about Bones in 2002 came four years after mine.

The Council on Foreign Relations

By far the largest and most prolific of the NWO organizations they are located in NYC in the Harold Pratt House on 58 E. 68th St. Total membership as of 2008 is 4,100 with about 240 corporate memberships. They have a staff of over 150. Founded in the early 1920's their flagship publication that is issued quarterly and is called *Foreign Affairs* that is widely circulated and available at many newsstands. The organizations primary published goals is world government, world judicial control, the elimination of national sovereignty, total

gun control in the hands of the military and police, and centralization of all governmental functions in a international body like the UN. In more exacting terms the CFR favors the same sort of governance as is exercised by the EU. This means that a huge group of bureaucrats that are unselected by the people are appointed by elected local hacks that then relinquish all legislative issues to the appointed bureaucrats. Just exactly the way Brussels acts as the EU legislative body. This by the way is the general plan for all of the various NWO organizations.

The CFR's means of controlling America are clever and unobtrusive. They function on a two tier system by which they firstly function through something they call "Study Groups". These groups are made up of CFR members and are directed as issue-based assemblies that meet regularly in closed sessions. In other words on any number of issue of hundrets of subjects there are established groups who then make policy relating to that particular issue. To implement these then developed polices CFR member see to it that CFR members are almost exclusively appointed as congressional staffers, members to the Joint Chiefs of Staff, cabinet members and advisors to the president all of which then implement the plans hatched in the Study Groups.

It is not unfair to say that advancement in the military, or the civilian bureaucracy is predicated upon membership in one of the organizations listed in this booklet. Advancement within the Legislative branch once elected is also predicated upon membership.

So that you have an understanding of the predominance of the CFR in the development of American domestic and foreign policy consider the below listed names.

The Trilateral Commission:

The Trilateral Commission was founded at the suggestion of Zbigniew Brzezinski (I, CFR) to David Rockefeller (I, B, CFR, TC, BG) at the Rockefeller estate in Westchester County NY at a meeting held on the 23rd and 24th of July 1972. The basis of Brzezinski's idea was that the CFR was basically a Domestic American organization and there needed to be an organization whose tentacles could reach across the industrialized Western World to optimize NWO power and influence. My book *The Satori and the New Mandarins* beginning on page 203 has an extensive dialogue on the TC as des Vale. The membership comprises somewhat over 340 members about equally located in Western Europe, Japan, South Korea, and the United States. Expansion into South West Asia as well as the Indian Subcontinent may be anticipated soon along with increased membership. Jimmy Carter was one of the first TC presidents his entire administration having been controlled by the TC. He was undoubtedly next to George Bush the lesser the worst president America had produced up to that time. The Bilderbergers:

One of the most secretive NWO groups in existence the Bilderbergers is primarily a European association but with considerable participation by members of the TC, CFR, and The Order. The Bohemian Grove:

Membership is by invitation only and if accepted the entrance fee is \$ 10,000. as of 2000.

The immediate plans:

- 1) The North American Union is planned to be the merging of the economies, politics and social structure of Canada, America and Mexico. - 3) The executives have advertised SPP (Security and Prosperity Partnership) as a security arrangement to protect the borders of the three nations. A premises that is patently ridiculous that it needs little commentary. Canada only has one border, which is America, Mexico borders Belize and Guatemala over 1,000 miles to the South of the US border, and Mexico is the primary security problem with the north not Guatemala or Belize. The plan to totally open the Mexican border would be an economic, social, and political disaster for America.
- 4) The Dollar, Loonie and Pecos are to be replaced with a new currency called the Amero. Don't try to tell me differently I have personally seen samples of the new currency.
- 5) While the Bush administration strenuously denies SPP as an existing treaty they have refused to release the names of any members of the CFR working groups involved in the negotiations with Canada and Mexico.
