

# **Illegal Immigration & Its costs**

While the Roman Catholic Council of Bishops spends every waking hour in effort to increase their flocks by inducing millions of Roman Catholic Hispanics from Mexico and Central America to sneak across our mostly unguarded border, America is drowning in a sea of debt in no small part caused by these illegal immigrants. The devastating effect of this massive population movement particularly from the Narco-Republic of Mexico is unprecedented in the annals of American history now anticipated at a staggering 24 million illegal aliens. While America has accepted millions of European immigrants, they were legal with papers. They wanted to become Americans, to contribute to our society, to work and produce, and most importantly to assimilate into American culture. Large percentages of the East and West European immigrants had skills that our nation could use. Second generation of these European immigrants had already assimilated and become Americans.

The difference with Hispanics is paramount. The large majority of Central American and Mexican alien illegal immigrants come to North America for one of three reasons, either they are trying to escape poverty or secondly they are escaping crime, terrorism, and the drug mafias or thirdly and this is a large percentage they come here seeking the welfare state, free hospital care, and private as well as state and national government handouts. Our idiotic immigration laws that make the child born to an illegal immigrant mother an American citizen upon birth is a large part of our immigration problem. By them not deporting her (child mother separation issues) she becomes an immediate welfare case costing hundreds of thousands of dollars by the time of the mother's citizenship, five years down the road, at which point she begins sponsoring her husband or boyfriend and all her relatives. None of these immigrants come here to assimilate or to become Americans, no indeed they come here to create a new Hispanic nation supplanting large parts of the South and Southwestern United States.

The difference between European and Central American immigrants could not possibly be larger. For one thing the new Central American and Mexican immigrants do not assimilate into our society. Many fourth generation Hispanic immigrants still speak Spanish as their primary tongue. A federal government that bends over backward to provide all information in Spanish does not help this and neither do Churches who provide masses in Spanish. There is no point in speaking of the individual states whose behavior on this issue borders criminality. We have been in Social Security offices where Spanish-speaking employees provided welfare services to Hispanic women with illegitimate children, who had never paid one cent into the system, at the cost to American taxpayers whose actual monthly payout were larger than that of retired American citizens who had spent a lifetime paying into the system.

The costs of government instituted and in many cases federally mandated illegal immigrant system costs the American taxpayer between \$36,000 and \$40,000 per year per illegal immigrant. It is a logical assumption that there are about eighty million taxpaying households in America so the facts would indicate that every American household incurs a tax burden of about \$10,800.00 per alien

illegal immigrant. These costs consist of but are not exclusive to; medical care, food stamps, welfare, compensation, education, penal costs, court costs, jails that have Hispanic populations exceeding 20%, housing, and not to be forgotten crime. Crime in fact has become the hallmark of the illegal population who through the Mexican drug cartels are the providers of the bulk of illegal drugs, marijuana, heroin, crack, and synthetics. In America Hispanic Street gangs distribute the drugs that they in part pay for with guns that they export to Mexico for the cartels that are now better armed than the Federales. The situation in Mexico has politically become untenable with the highest murder and kidnapping rate in the world, and a rapidly destabilizing government. Just in Ciudad Juarez over 4,000 murders in just 2008. Among the killings have been the head of the federal police force, and police chiefs in numerous border cities.

Due to our unprotected borders this Mexican drug violence is spilling across the border into Arizona, California, Texas, and indeed the entire Southwest.

The immediate result of this immigration horde is first noticed in our hospitals. An interesting case is a lady who had a badly cut finger. During the 1960's under normal circumstances she would have been treated in the emergency room, by giving her a painkiller, cleaning the wound and if necessary x-raying it, bandaging it and sending her on her way with a bill for about \$50.00. Today this is all very different. When she arrived at a hospital in Florida she was number 75 in line directly behind 75 Mexicans. After bleeding on the floor for three hours she saw an intern who then treated her and then sends her to billing. Billing demanded her credit card and billed her \$ 100.00 the balance to come by invoice to her home. Three weeks later she gets a bill for \$850.00. The hospital in fact padded the bill for the American patient to make up for all the Mexicans who will not be billed. (1) Stupid federal laws require that no hospital can refuse to treat any malady regardless of financial considerations relating to the case. Mexican's get free healthcare and Americans pay for it through inflated billings. Because the lady was under 65 she was not covered by Medicare or Medicaid, and because due to cost she had a \$1000.00 deductible on her private health insurance she was forced to pay the bill out of pocket.

Oh, let me not be negligent and tell you that in the Obama Economic Recovery plan of some \$1.5 trillion and growing, due to the government having to borrow it all, includes a tax rebate of \$ 5,000 ea. for people who did not pay taxes due to income and that illegal's will be a large portion of that outlay.

As our economy gets worse Americans are being squeezed in many ways. Food costs have risen about 25% in the last eight years as everyone knows incomes have not increased at the same rate as inflation that with corrected non-government numbers topped 13% in just 2008. Most illegals get food stamps because their reported income is below poverty level. Well actually, probably not, but they are clever enough to arrange reporting statistics to place them on the welfare bandwagon. The fact of the matter is, that most American Social Security retirees are about 5% above the allowable income level to obtain food stamps; some are eating dog food to improve their meat content diet.

In higher education Hispanics are given preference in scholarships, as well as admission to colleges and universities. In some states illegals actually can get into two year state colleges for free, while the rest of us pay through the nose. When the average Joe sends his son to an out of state college to university he pays high out of state charges not illegal's they mostly go free, most American families can't afford this so they must opt for the local school even if it is not the best for the major of the intended student.

To say that we are fed up with this system is a major understatement. The bureaucrats and politicians in Washington have made us, the American taxpayers third class citizens in our own country. The first class citizens in the 21<sup>st</sup> century are the Mestizos the second the blacks and those who pay the bills are third. And please don't roll out that tired old canard of racism by Caucasians, because that card won't play in this venue' or this century.

Our own government admits that about 30% of all illegal immigrants are on welfare and food stamps and that less than 2% of them are working in agriculture. In our Senate the morons who are paid (very handsomely) to represent our interests voted to grant Social Security Benefits to illegal immigrants beginning in 2009. Illegal immigrants are the by percentage the largest group of sex ofendes and child molesters accounting for over one thousand sexual assaults in every year. (2) About 30% of all federal inmates in federal penitentiaries are Mestizos. Thee fourths of all most wanted federal warrants are for illegals. 95% of all outstanding murder warrants are for illegals. One fourth of California's detention centers are comprised of illegals. These statistics are only partial but they are incriminating of our elected officials who have failed the American taxpayers miserably in a vain effort to bolster their political parties with new members.

At the crux of this entire issue is as always the political desire for re-election. The "System" i.e. Republocrats have carefully taken note of the fact that these illegal's represent a potential voter pool of over 20 million potential citizens voters for their party, so, like a bunch of power drunk idiots they have begun chasing those votes with promises that are endless and that they will never in a thousand years be able to fulfill. Unfortunately some of these promises have already been fulfilled. Affirmative action, hiring preference, college admission preference, ethnic studies glorifying the Aztec human sacrifice culture and denigrating Western Culture, and coming to you in 2009 will be amnesty and citizenship within five years, i.e. Obama's second term to ensure democrat supremacy of America for the coming sixteen years.

It is particularly in the lower income groups and in the middle management areas where our largest loss of jobs is apparent. Middle management is being outsourced to India, Pakistan, and the Philippines, while at the same time lower blue-collar jobs are so greatly disputed over that wages are being suppressed in a contracting market.

This begs the question, to whose benefit are these policies. For any nationalist this is a rather simplistic question. The obvious only benefactors to these policies are large multinational corporations, which through these strategies are able to depress all workers wages on an international scale. Unemployment in America has been rising for the last ten years, now being at 17%, and we suggest will top 20% in the second quarter of 2009. If immigration is not halted, remember we grant 3 million immigration visas every year and have over one million illegal's coming in per year, the pressure on lower income jobs will result in drastically lower wages in an economy that will see large increases in prices of all goods due to dollar devaluation as well as inflation. The decline of dollar value must not be underestimated because due to the multinational corporate pressure on the body politic we have been exercising a national policy of "Free Trade" that has proven to be the Trojan Horse destroying our national manufacturing base.
